Meter Deposits

Mora Municipal Utilities requires a meter deposit on applications for utility services from renters, real estate agents and manufactured home owners. This deposit is retained as security towards a final bill until payments have been received on time for twelve (12) consecutive months. After the twelfth consecutive payment is received by the due date, Mora Municipal Utilities will issue a credit back to your account for the amount of your deposit plus interest earned from the date the deposit was paid, in the subsequent billing cycle.
