SUMMARY

The City of Mora added streets for overlay to Kanabec County's blacktop bids to receive a lower price per yard and ensure the best value. Kanabec County board will close bids May 30th and formally accept the low bid at the next board meeting June 6, 2023. Due to the nature of the projects, there are significant savings when ordered in large quantities.

BACKGROUND INFORMATION

Due to the conditions of some of the roads in town, staff requested to be put on the quotes with Kanabec County to propose material at a reduced rate. The streets identified are Village Green Lane, Village Green Place, Locust Street, Snake River Canoe Park Access, and Oakwood cemetery. Village Green Place and Lane, Locust, and Canoe Park have not fared well over the winter and staff feels that repair/overlay is needed to prevent extreme maintenance next year. Cemetery overlay/paving is needed to complete last year's project and to extend the road life. Bids will be discussed at this meeting to accept or change street overlay project selections. Funds will be used from the Future Improvement Fund – Medium Duty Dump Truck (\$77,215.00) and unused 2021 Small Cities Grant Money (\$68,413.00) retained for patching and paving. Appropriate budget amendments and interfund transfer requests will be presented at the June 20th, 2023 council meeting.
