- 1. <u>Call to Order.</u> Chair Brockner called the meeting to order via a public WebEx virtual meeting at 6:05 p.m.
- 2. Roll Call. Present: Brockner, Hosley, Kringstad, Mathison,
- 3. Adopt Agenda. Motion made by Kringstad, second by Mathison:

Ave: Brockner, Hosley, Kringstad, Mathison

Motion unanimously carried to approve the May 5, 2020 agenda as present.

4. Minutes. Motion made by Kringstad, second by Mathison:

Aye: Brockner, Hosley, Kringstad, Mathison

Nay: None

Motion unanimously carried to approve February 4, 2020 Meeting Minutes.

- 5. Fall Fest. The board had a good discussion on the upcoming season of Fall Fest tentatively set for September 26, 2020. Krie presented the board with an Event Detail Sheet to help with discussion and planning. Krie also mentioned that he had reach out to Coburns Pumpkin Painting, Quality Disposal Face Painting, and the Chamber Hay Maze and they are on board with hosting those stations. The board discussing was mainly centered on COVID-19 and what challenges that might bring. Brockner mentioned that Kettle Corn has committed to the event but may use a tent instead of a wagon. Mathison commented that food vendors might be reluctant to commit this early due to COVID-19 concerns. The COVID-19 concern conversation turned to Music in the Park by Hosley. Krie said this has been discussed by staff and if the Governor allows then we will go forward and have a social distance plan in place. All agreed that if possible, Music in the Park and Fall Fest should happen and to table discussion on Fall Fest to June or July to see where the status of COVID-19 is.
- 6. <u>Fox Run Future Park.</u> Krie presented board with a tentative bid and design from Midwest Playscapes to see what direction they wanted to take. Krie also mentioned that staff was looking at other options in that area to add more land. The board discussed and all agreed to reduce the

amount of playground equipment initially and build up the area in stages to help with cost. Hosley mentioned that doing in stages we could monitor how much usage the Park was getting before adding more features. This matter would be tabled and brought back up to the board once discussion has taken place by staff on how much land is available for a park.

7. <u>Snake River Trail Proposal.</u> Krie present the Park Board with MDOTs latest bridge/trail proposal. Kohlgraf provide details of the expansion regarding the bridge and trails and what was expected from MDOT. All members were enthusiastic about the project. Mathison made a motion to approve and send this to Council for review, Kringstad second:

Motion unanimously carried to propose Snake River Trail Proposal to City Council for approval.

- 8. Parks. Brockner brought up to staff if there was any thought given to opening the Playgrounds and to why they were closed and suggested options to help with the opening. Kohlgraf gave details of the decision made by staff and that staff will revisit playgrounds in the upcoming weeks. Brockner also mentioned if staff could post something about playgrounds letting the community know why they were closed and to when they might open it might be helpful. Krie said he would bring Park Boards discussion to staff,
- 9. Reports.

Kohlgraf reported to the board about the following:

- Tennis/pickle ball courts are scheduled for the next month, depending on temp.
- Structure sealing for the gazebo, and kids' kingdom are scheduled for this year.
- Monthly maintenance checks will resume when playgrounds open back up.

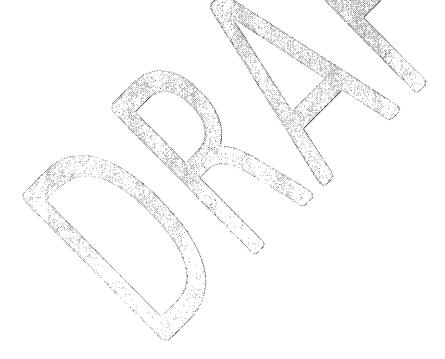
Krie reported to the board the following:

- Community Garden and that weather permitting the water will be turned on around May 19th.
- Krie mentioned that Kids Kingdom was brought up to the Lions Club on safety and security of the structure and area. Kohlgraf mentioned that he would look at what was needed to put up two lights and cost associated with that and give it to Krie to see if the Lions could help with funding the cost.
- Krie also talked about the Park Board opening and Mayors expectations. One application had been submitted and another was being presented.
- Krie also informed Park Board of Councils decision to close the MAC for the 2020 season and a press release will be forthcoming.

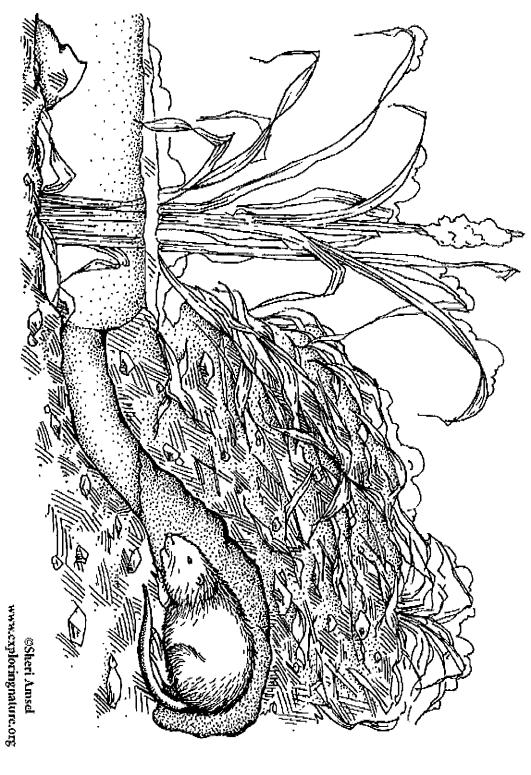
