- 1. Call to Order. Chair Brockner called the meeting to order at 6:04 p.m.
- 2. Roll Call. All board members were present except Sadie Hosley.
- 3. Adopt Agenda. Motion by Kringstad, second by Mathison to adopt the February 4, 2020 meeting agenda as presented. All present voted aye. Motion carried.
- 4. <u>Minutes.</u> Motion by Mathison, second by Kringstad to approve the January 14, 2020 meeting minutes as presented. All present voted aye. Motion carried.
- 5. Fall Fest. The board had a good discussion on the upcoming season of Fall Fest tentatively set for September 26, 2020. Krie presented the board with an Event Detail Sheet to help with discussion and planning. The board discussing was mainly centered on food trucks to get commitments early and to get a good variety for Fall Fest. Kringstad will reach out to food trucks via the Facebook site and as vendors commit or reach out, she will give that information to Krie to follow up on. Brockner mentioned to reach out to Debbie Morrison at Sapsucker Farm to see how they are so successful with their food truck program so we can get a variety of vendors. Brockner also mentioned Potato Wagon and Kettle Corn and Kringstad mentioned Coffee Place and Pizza Pub as possible vendors for the event. Mathison recommended Grandstand as a possible vendor. Krie mentioned that if we could get a commitment from the food vendors that way they could be in the advertisement. Kringstad suggested to use advertisement to get an early commitment from food vendors. The discussion went from food vendors to activities and eyents. Kringstad suggested to look at getting a Bounce House with no slide to help with safety. Mathison suggested if needed to ask police reserves to help with safety controls. Kringstad mentioned and the board agreed that we should add hair coloring to go with face painting station instead of the coloring station. Krie mentioned that he will reach out to the community and start to find sponsors for the event. More discussion on Fall Fest will be discussed in upcoming months.
- 6. <u>Fox Run Future Park.</u> Board discussed Fox Run Future Park sites and possible playground equipment and ADA playground regulations. Brockner asked if there were funds available for Parks to purchase equipment? The Board felt there was no reason to have an open forum or discussions with neighborhood at this time. Krie will reach out to vendors to get some ideas on

equipment and cost and ADA regulations. Mathison mentioned reaching out to FCB on a grant to help get funds started for Fox Run. Krie mentioned he is looking at other grants to help fund the project. Brockner suggested if funds are low to start small and supply park with more equipment as the years go on and to make sure equipment is for all ages. Brockner suggested to delay any more discussion until funds are available for purchase and the board agreed.

7. <u>Dog Park.</u> Krie present the Park Board with a possible parcel of land that the city owns IP address 22.00075.00 for a possible dog park site. Board discussed possible options and cost. Brockner suggested and the Board agreed that the Dog Park should be secondary behind the Fox Run Future Park in funds and to end discussion unless this matter is taken up by the community.

8. Project Updates.

- a. Krie reported the following:
 - The Music in the Park Grant to ECRAC was submitted for review and all bands are confirmed for 2020 pending grant approval.
 - Looking at grants for playgrounds and trails.
 - Submitted grant for Library Doors through FCB.
 - Safety Committee is looking at park safety in Kids Kingdom and that Krie will reach out to the Lions Club to gauge interest.
 - Krie will be reaching out to sponsors for Music in the Park and Fall Fest to help support upcoming event cost.
- 9. <u>Adjournment.</u> Motion by Mathison, second by Kringstad to adjourn the meeting. All present voted aye. Meeting adjourned at 6:45 p.m.


