2016 CONSUMER CONFIDENCE REPORT

A DRINKING WATER QUALITY REPORT FOR THE CUSTOMERS OF MORA MUNICIPAL UTILITIES AND THE CITY OF MORA, KANABEC COUNTY, MINNESOTA - JUNE 2017

In compliance with the Federal 1996 Safe Drinking Water Act Amendments, the Mora Municipal Utilities (MMU) is providing its water customers with this report on the quality of our drinking water. This report presents data compiled during the twelve months from January 1 to December 31, 2016. The purpose of this report is to advance consumers' understanding of drinking water and heighten awareness of the need to protect precious water resources. Reports are published and distributed to customers in June of the following year.

SOURCE OF WATER

Our Water Source – Our water comes from a groundwater source; three wells ranging from 195 to 210 feet deep that draw water from the Quaternary Buried Artesian aquifer.

Source Water Assessment – The water provided may meet drinking water standards, but the Minnesota Department of Health (MDH) has also made a determination as to how vulnerable the source water may be to future contamination incidents. RESULTS OF MONITORING

No contaminants were detected at levels that violated the Federal drinking water standards. However, some contaminants were detected in trace amounts that were below legal limits. Some contaminants are sampled less frequently than once per year; as a result not all contaminants were sampled for in 2016. If any of these contaminants were detected the last time they were sampled for, they are included in the table along with the date detection occurred.

TERMS

AL	= Action Level, the concentration of a contaminant which triggers treatment or other requirement which a water system must follow.
MCL	= Maximum Contaminant Level, the highest allowable amount of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
MCLG	= Maximum Contaminant Level Goal, the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
MRDL	= Maximum Residual Disinfection Level.
MRDLG	= Maximum Residual Disinfection Level Goal.

90 th percentile level	= This is the value obtained after disregarding (10%) of the samples taken that had the highest levels. For example, in a situation in which ten samples were taken, the 90 th percentile level is determined by disregarding the highest result, which represents 10% of the samples. In situations in which only five samples are taken, the average of the two with the highest levels is taken to determine the 90 th percentile level.

<u>Notes</u>

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. MMU is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for thirty (30) seconds to two (2) minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. COMPLIANCE WITH NATIONAL PRIMARY DRINKING WATER REGULATIONS

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive materials. Water can also pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water that must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. YOU SHOULD KNOW ...

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune disorders, some elderly and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. SYSTEM INFORMATION

Treatment – Our water is treated with chlorine to eliminate coliform bacteria and it is treated with fluoride to promote dental health. Our water is also treated with ammonium sulfate to control HAA5 and TTHM, as well as treated with caustic soda to control pH which helps reduce lead and copper contaminants. Our water is also filtered and treated with potassium permanganate to remove iron and manganese. In mid-2016 MMU reduced the amount of fluoride we added to the water by almost 50%. This change was the result of studies by the U.S. Department of Health & Human Services and the Center for Disease Control and Prevention along with the concurrence of the Minnesota Department of Health. This reduction balances the benefits of tooth decay while limiting any potential negative health effects such as dental fluorosis.

Hardness – Our water hardness is 7-10 grains.

Pressure – Our typical water pressure is around fifty pounds per square inch (50 psi). It can range from 43 psi to 62 psi depending your location on the water system.

Usage – Over 114 million gallons of water was pumped in 2016 to supply approximately 1,200 homes, businesses, industries and other customers. The water system serves about 3,600 people. Water is pumped into two elevated storage tanks of 150,000 and 500,000 gallons and a 50,000 gallon clear well to provide consistent water pressure and short-term storage.

Infrastructure Maintenance –Wells and pumps are pulled and thoroughly inspected by qualified professionals every ten (10) years. Water towers are cleaned and inspected every five (5) years.

Financial Information – Municipal water systems are supposed to be self-supporting financially, without contributions of tax dollars. In 2016 the water system had expenditures of \$594,661 and revenues of \$682,339. The resulting surplus of \$87,678 was due to water sales higher than projected, access fees for new construction, and savings on wages & benefits. The surplus will be maintained in the water fund reserves that amounted to \$831,727 at the end of 2016.
